

2. Source of funding

- 2.1. The Roads Authority (RA) has received financing from the Roads Fund toward the cost of the Consultancy services to Undertake Road Sector Designs Lot 1 and 2 and Road Sector Studies, and it intends to apply part of the proceeds toward payments under the contracts.
- 2.2. The RA now invites proposals from eligible bidders for the Consultancy services to Undertake Road Sector Designs and Road Sector Studies, using work package Instructions.

3. Bidding procedures

3.1. Bidding will be conducted in accordance with the open national tendering procedures contained in the Public Procurement and Disposal of Public Assets (PPDA) Act (2017) and the Public Procurement Regulations of 2020 of the Government of the Republic of Malawi and is open to all eligible bidders.

- 3.2. All eligible bidders are required to show evidence of registration with the National Construction Industry Council of Malawi (NCIC) and will have renewed their membership for the current financial year.

Bidders should note that while access to the RfP is free, proposals received will only be considered for evaluation if accompanied by proof of deposit or transfer of an amount of MWK30,000.00.
